 - b. Will not be any specific dramatic changes to the budget
 - c. Instructions to Housing Dept. was to budget fairly flat
 - d. Availability of County Property Tax Money? Anne stated that the money is not going to specifically be funneled to housing; General Fund money will continue and may slightly increase over the years.
