### Pasadena Partnership

The Pasadena Partnership is the lead agency for the Pasadena Continuum of Care (CoC). The CoC is the local planning body that coordinates housing and services funding for homeless families and individuals. Currently, Pasadena Partnership is one of four CoCs in the LA area: LAHSA, Pasadena, Glendale, and Long Beach.

### **Homeless Planning & Research Committee**

The Pasadena Partnership's Homeless Planning & Research Committee meets monthly and focuses on improving CoC-wide participation in mainstream resources and program, developing the CoC's coordinated assessment system, and implementing strategies that provide a wide-range of social services. This special meeting of the committee will focus on the 2016 Homeless Count.

#### 2016 Homeless Count

Each year the Pasadena Partnership conducts a homeless count (also called a Point-in-Time Count). The Homeless Count is a one night count of sheltered and unsheltered homeless persons conducted during the last week in January (this year's count will be on Wednesday, January 27). The results of the count are reported to HUD and Congress and, together with other CoC Counts, are used to determine billions of dollars of federal funding (see HUD's 2015 AHAR Reports for more information).

Pasadena's homeless count uses a "true count" methodology, meaning that we count each person rather than taking a sample of the homeless community. Individuals are asked detailed questions to determine our homeless population's demographic makeup (including age, gender, veteran status, metal health, etc.) and our methodology to avoid duplication has been featured in HUD's last two publications on Homeless Counts.

This year, because homelessness has become more visible today than in the past (despite the fact that the numbers have gone down), we are making a concerted effort to be completely transparent and include the community in our planning process for the count. The sighting of tents on the sidewalks and underpasses that has become more common in Pasadena this year is unusual for us, and it is important for community members to understand that this increased visibility is due to the increased needs of this population and does not necessarily correlate with an increase in number.

#### HUD's definition of homelessness

One important reminder for the community is that the homeless count only counts those people who meet HUD's current definition of homelessness (24 CFR 578.3). Accordingly, for the purpose of the count, homeless means an individual or family who lacks a fixed, regular, and adequate nighttime residence, meaning:

- An individual or family with a primary nighttime residence that is a public or private place not designed
  for or ordinarily used as a regular sleeping accommodation for human beings, including a car, park,
  abandoned building bus or train station, airport, or camping ground (this does not include persons living
  in housing that is substandard and in need of repair, housing that is crowded, or individuals who are
  "couch surfing"); or
- An individual of family living in a supervised publicly or privately operated shelter designed to provide temporary living arrangements (including congregate shelters, transitional housing, and hotels and motels paid for by charitable organizations or by federal, State, or local government programs for low-income individuals); or
- An individual who is exiting an institution where he or she resided for 90 days or less and who resided in an emergency shelter or place not meant for human habitation immediately before entering that institution
