Introductions / Approval of Minutes

Members of the committee introduced themselves. Minutes from the June and August Faith Community meeting were read and approved.

Review of FCC Mission Purpose & Success Stories

Presenter: Dan Davidson

- Mission statement was reviewed in order to remind us what the mission of the FCC is and keep us on track
- The FCC remains committed to learn about and support evidence-based and best practices to prevent and end homelessness in Pasadena
- Meeting monthly to align with what the City of Pasadena is doing to end homelessness
- The role of the faith based communities is to help be part of the solution to end homelessness
- FCC to set the example of religious organizations working with civic government, a model that can and should be used in other cities
- Mission statement is posted on Pasadena Partnership website and will be added to the Tool Kit
- We want to recruit other faith based organizations to join our committee, all new members are welcome
- Anne shared that Perry received non-elderly disabled funding for housing, but was not tied to permanent supportive services. After a year housed he became homeless once again in Pasadena for an additional 2-3 years. With help and support from Union Station he has once again found housing here in Pasadena. The story does not end there, as he will probably continue to be in need of supportive services for the rest of his life.
- Sofia shared that Sabrina was assisted by Union Station and spent 8 months in transitional housing and has recently become housed
- Sofia shared that Maria after 15 years of being homeless on the streets, with the collaboration between Salvation Army, Union Station, and HOPE Team has entered and remained in a shelter for the last 3 months
- The work does not end when a person becomes housed, but rather it begins, as supportive services are vital to helping a person remain housed

- Than has handed off his duties to Colton to work on the Tool Kit
- Than will now head the subcommittee: Focus Moving Forward
- Terry reported that Focus Moving Forward subcommittee has met to identify the issues of homeless prevention. The focus of the committee is on group C, those at risk of becoming homeless
- In Pasadena 10% of families are at risk of becoming homeless (approximately 700 families)
- How can faith communities come along to help prevent and support those newly homeless?

- Invite Friends in Deed and Foothill Unity Center to be part of the sub committee
- Risk factors involved for those at risk of homelessness: identify the risks
- All Saints has been approached about their legal aid services and will be presenting to the FCC in the near future
- Yes in my back yard YIMBY should also be part of the conversation for the Focus Moving Forward subcommittee
- Lake Avenue has spent 95K in the last year in homeless prevention services/funds
- Friends in Deed receives 25k from the city of Pasadena for homeless prevention services
- Important to keep outcomes after an individual or family are help with homeless prevention services
