- FCC is a subcommittee of the Homeless Committee which is a committee of the COC
- Meeting monthly to align with what the City of Pasadena is doing to end homelessness
- The role of the faith based communities is to help be part of the solution to end homelessness
- FCC to set the example of religious organizations working with civic government, a model that can and should be used in other cities
- Mission statement is posted on Pasadena Partnership website and will be added to the Tool Kit
- We want to recruit other faith based organizations to join our committee, all new members are welcome

Stories of Success

Presenter: Dan Davidson

- Anne shared the story of a women who lost her house about five years ago due to foreclosure. She connected with a local church and Jackie Robinson Center. A unit in Pasadena was found for her, but she felt unsafe and left the unit after less than a year. She then went to live at Union Station's shelter. A second unit was found for her. Unfortunately, due to her disabilities, she left the unit after 1.5 years. She has now found a third unit and continues to receive supportive services to help her remain in her unit.
- Anne shared the story about a woman homeless in the park. She refuses to leave the park, but the street outreach team has connected with her for about a year now. Outreach team will offer to transport to Union Station's Thanksgiving dinner in the park, but if she refuses to go, an outreach team member will take a meal to her.
- Pastor... shared the story of Kathryn who walked from the Alhambra jail to Pasadena Church on October 27th (a Friday). She was fed that night and church members pooled their funds together and paid for a motel for the weekend. She was connected with CES and has completed the ViSPDAT. At the moment she is being housed in a rented, but not yet occupied unit. Church members continue to provide her support and accompany her to her appointments.
- FCC members provided many suggestions to Pasadena Church to help Kathryn navigate services.

- Jill shared she is working with The Quaker Room to help Laventine, a homeless youth. He was taken to Youth Moving on and will continue to assist him in navigating services.
