Request for Proposals (RFP) for Bonus Funding

Pasadena Continuum of Care (CoC), Issued July 13, 2018

Overview

The City of Pasadena, as Collaborative Applicant for Continuum of Care Homeless Assistance Funding from the U.S. Department of Housing & Urban Development (HUD), is seeking a qualified nonprofit agency to act as Project Sponsor to apply, as part of the 2018 Continuum of Care (CoC) Competition, for Bonus and Reallocation funding in conjunction with the City of Pasadena Housing Department.

Available Funding

Approximately \$189,795 of Bonus Funding and \$85,000 for the CoC reallocation process is available. Final amount available for CoC Bonus funding will be available once HUD posts the Final Pro Rata Need (FPRN) on the HUD Exchange. The Pasadena CoC will only submit one project application to HUD for the Bonus Funding and one project for the Reallocation Funding and therefore applicants should apply for the full amount of funding available.

Prioritized Projects

The following list is prioritized based on current needs in the Pasadena CoC service system:

- 1. Homeless Management Information System (HMIS)
- 2. Project-Based Permanent Supportive Housing (PSH) dedicated to chronically homeless persons;
- 3. Tenant-Based PSH dedicated to chronically homeless persons;
- 4. Permanent Housing-Rapid ReHousing (PH-RRH) that serve homeless individuals and families including unaccompanied youth;
- 5. Supportive Services Only (SSO-CE) project to operate a coordinated entry system.

Mandatory Workshop

Agencies interested in applying for the Bonus and Reallocation Project Funding are required to attend the workshop for new projects hosted by the City of Pasadena Housing Department. Details for the workshop are as follows:

Deadline

Proposals must be submitted via e-snaps by 5:00 pm on Thursday, **August 2**, **2018**. Responses submitted later than 5 pm will not be accepted.

Introduction

The City is accepting proposals for new projects or the expansion of current projects with CoC Homeless Assistance funding from HUD. The Pasadena CoC is soliciting proposals that address housing and service priorities established through the Pasadena CoC.

The projects being solicited will be innovative and highly effective and increase housing resources for vulnerable populations or build capacity within the Pasadena Coordinated Entry System. Projects are encouraged to show collaboration among providers and leverage mainstream resources to support highly vulnerable chronically homeless individuals. Priority will be for projects that have a plan for securing dedicated housing units for the project.

Project Requirements

Funding will come from the U.S. Department of Housing and Urban Development's (HUD) 2018 McKinney-Vento Continuum of Care (CoC) for the Homeless Program, as amended under the HEARTH Act and the CoC Program Interim Rule. The availability and priorities for any funding for new projects is articulated in HUD's CoC Notice of Funding Available (NOFA): https://www.hudexchange.info/resource/5719/fy-2018-coc-program-nofa/

Organizations that do not currently receive Pasadena CoC program funding are encouraged to submit proposals. Proposals are also welcome from current recipients of this funding, provided the proposed project creates new housing opportunities for those experiencing homelessness.

Project Timeline

HUD publishes a CoC Notice of Funding Availability (NOFA) for each funding year. This RFP is being released in support of the 2018 CoC NOFA released on June 20, 2018. A single, consolidated submission of all selected projects in Pasadena will be submitted to HUD by the City of Pasadena which is the Collaborative Applicant. The Pasadena CoC will submit the application no later than September 18, 2018. Funding will be derived from Federal Fiscal Year 2018 allocations of HUD funds and is subject to funding approval by HUD.

Proposed Project Requirements

The Pasadena CoC seeks one or more qualified applicants to administer new or expanded programs to serve homeless individuals consistent with the guidance provided by the U.S. Department of Housing and Urban Development (HUD) including, but not limited to, ending homelessness for all persons, creating a systematic response to homelessness, strategically allocating and using resources, and using a Housing First approach.

Competitive Proposed Projects Will:

- Clearly meet the CoC Program funding opportunities of HUD and the Pasadena CoC;
- Have a clear plan for acquiring dedicated housing units for the project (PSH & PH-RRH);
- Describe a housing first and trauma-informed service delivery approach, including low-barrier access to the housing and services that will work effectively with the Pasadena Coordinated Entry System;
- Be based upon best practices and the most effective, evidence-based, culturally competent, and individualized client models possible;

- Include plans to successfully meet HUD and local performance measures (PSH & PH-RRH);
- Be administered by organizations that have demonstrated experience providing similar services and serving the proposed population (all project types).

Eligible Applicants

Applications will only be accepted from eligible nonprofit agencies, units of government and public housing agencies.

General Requirements

With the exception of renewal grants, HUD will only fund new or expanded projects. Funds cannot be used to close a funding gap or replace lost funding in an existing housing project or service program. Project applicants must demonstrate that they are not replacing other funding sources. The population to be served must be homeless or chronically homeless as defined by HUD. Timeliness

Projects must be able to meet timeliness standards. The applicant is expected to initiate approved projects promptly in accordance with the requirements that are specified in the 2018 NOFA. Grant terms and associated grant operations may not extend beyond the availability of funds. Applicants must plan accordingly and only submit applications that can achieve project goals and outcomes within the specified grant term.

HUD Eligibility Requirements

Applicants must meet HUD recipient and/or sub-recipient eligibility requirements.

HMIS

Participation in the Homeless Management Information System (HMIS) is required of all HUD grant recipients.

CES

Participation in the Pasadena Coordinated Entry System (CES) is required including filling units with referrals from CES and prioritizing resources for the most vulnerable persons and households.

Match

Match funds are required, as described by HUD: "Match and Leverage are two distinct categories of program funds that are acquired from other sources not associated with this grant request. Match funds must be used for program eligible costs only and must be equal or greater than 25 percent of the total grant request for all eligible costs with the exception of leasing costs."

Supportive Services (PSH & RRH)

Permanent Supportive Housing and Rapid Re-Housing projects must provide on-site supportive services or have an agreement in place for a partner agency to do so.

Project Types

Permanent Supportive Housing (PSH)

In order to increase the number of beds specifically for the chronically homeless population and work towards the goal of ending chronic homelessness in Pasadena, CoC's will be able to apply for new or expanded projects for Permanent Supportive Housing (PSH) that meet the requirements of Dedicated PLUS as defined in Section II.C.3.f of the NOFA or where 100 percent of the beds are dedicated to individuals and families experiencing homelessness, as defined in 24 CFR 578.3. All project must comply

with the Pasadena PSH Written standards available at: https://pasadenapartnership.org/psh-written-standards/.

Eligible activities include: Leasing, Rental Assistance, Supportive Services, Operations and HMIS. All components require a 25% match except for leasing. Leasing also requires that rent not exceed Fair Market Rent. Information on eligible activities and expenses can be found in the Interim Rule (https://www.hudexchange.info/resource/2033/hearth-coc-program-interim-rule/).

Rapid Re-Housing (RRH)

In order to increase the supply of permanent housing options, CoC's will be able to submit applications for new or expanded Permanent Housing-Rapid Re-Housing (PH-RRH) programs. Competitive proposals will have a clear plan for assisting homeless individuals and families secure rental housing in Pasadena's competitive market. Expanded programs must propose to increase the number of persons/families served by their currently funded program. All project must comply with the Pasadena RRH Written standards available at: https://pasadenapartnership.org/rrh-written-standards/

Eligible activities include: Rental Assistance, Supportive Services, Operations and HMIS. All components require a 25% match. Information on eligible activities and expenses can be found in the Interim Rule (https://www.hudexchange.info/resource/2033/hearth-coc-program-interim-rule/).

Supportive Services Only for Coordinated Entry (SSO-CE)

The Supportive Services Only (SSO) for Coordinated Entry (CE) component allows recipients to develop or operate a centralized or coordinated assessment system. The system must be easily available/reachable for all persons within the CoC's geographic area and be accessible for persons with disabilities. There must be a strategy for advertising to reach homeless persons with the highest barriers.

Eligible activities include: Supportive Services, HMIS and Project Administrative Costs. Information on eligible activities and expenses can be found in the Interim Rule (https://www.hudexchange.info/resource/2033/hearth-coc-program-interim-rule/)

HMIS

Dedicated HMIS Project for the costs at 24 CFR 578.37(a)(2) that can only be carried out by the HMIS Lead, which is the recipient or subrecipient of an HMIS grant, and that is listed on the HMIS Lead form in the CoC Applicant Profile in e-snaps.

Evaluation Procedures and Criteria

Project Quality & Performance Threshold Requirements

Project Quality

To meet project quality threshold, new project applications must fulfill the following criteria:

Selection Process

Projects responding to this RFP will be reviewed and ranked by an independent Grants Evaluation Committee. Projects will be reviewed in reference to the project's consistency with community needs, the project's ability to enhance system performance, the agency/collaborative capacity to enhance system performance, and financial efficiency and management. The Pasadena CoC Ranking and Selection scoring tool for Bonus and Reallocation Funding project will be posted online by Wednesday, July 18 at: https://pasadenapartnership.org/coc-new-projects/

Applicants will be notified of preliminary recommendations by August 9, 2018. Projects that are not recommended for funding have the ability to appeal the Grants Evaluation Committee's decision to the Pasadena CoC Board on August 14, 2018. Agencies wishing to appeal must notify the City in writing by August 13, 2018 at noon.

Proposals/Applicants who are approved to move forward to be submitted in the CoC Consolidated Application will work with CoC staff to revise applications to be most competitive in the CoC application process.

Award of Funds

The project selected by the Continuum of Care Board will be notified on August 15, 2018. Please be aware that applications need to be finalized in e-snaps and submitted to the CoC Collaborative Applicant by noon August 15, 2018. If the funding is awarded by HUD, grant funds are estimated to be made available by HUD by the first half of the 2019 calendar year. The timing of awards and grant-making by HUD is outside of the control of the City of Pasadena. Therefore, agencies seeking and receiving new funding must be aware of all operating year start and end dates and must make arrangements to cover any period in which a HUD funding award is pending, delayed, or not awarded.
