HOMELESSNESS PLAN UPDATES

Over the summer, extensive community engagement took place, supported by a robust systems analysis.

216

SURVEY RESPONSES

In July, 216 people responded to our survey, offering feedback on system priorities, goals, and areas for improvement.

INTERVIEWS

In June + July, PPA conducted nine interviews with ten system and regional partners.

FOCUS GROUPS

In July that allowed for in-person engagement with 57 people with lived experience of homelessness.

UISTENING SESIONS

Throughout the summer and early fall, including CoC members + four City Commissions.

HHAP UPDATE

HHAP-3 goals were conservative based on state recommendations, as bonus funding was dependent upon successful achievement of the goals. On Thursday November 3rd, the Governor "rejected" every jurisdiction's HHAP action plan for not being aggressive enough and is pausing disbursement of the remaining HHAP 3 funds.

> NO FORMAL COMMUNICATION ON HHAP-3

The CoC has yet to receive communication from the state on the matter, so we don't yet know how this will impact our funding plans. The CoC doesn't plan on using the second disbursement (80%) of HHAP-3 funds until FY 24.

IMPACT ON HHAP-4

We don't yet know how the governor's announcement will impact HHAP-4. As far as we've heard, the state has not changed the deadline or guidance around the application.

HHAP-4 OVERVIEW

FUNDING ALLOCATIONS HHAP-4 allocations are not yet available but will be based on local 2022 Point-in-Time (PIT) Homeless Counts.

We anticipate similar HHAP-3 and HHAP-4 allocations, as 2022 PIT was just 4% lower than 2019. The board will be voting on funding proportions, not specific dollar amounts for eligible activities.

APPLICATION REQUIREMENTS

Like HHAP-3, the CoC is required to establish quantifiable performance goals and strategies to support these goals. The Governor's announcement came after HHAP-4 goals were developed. We're waiting to hear from the State on updated recommendations.

Homelessness plan goals will be separate and distinct from HHAP-4 goals, reflect local priorities, and be developed through our own analysis.

Strengthen the Emergency Support System

In Pasadena, people are experiencing homelessness for longer periods of time. The emergency support system plays a critical role in meeting people's basic needs until they find permanent housing.

RESPONSE COORDINATION & REFERRALS

Develop a more accessible, transparent, and timely response coordination and referral system that connects people to emergency services while they work towards permanent housing.

ESSENTIAL SERVICES

Continue to fund essential services such as showers and investigate options to add a multi-service center.

EMERGENCY SHELTER

Investigate options to maintain/expand shelter beds, particularly those with extended stays and case management services. Promote dignity and respect by ensuring safety, security, and cleanliness of shelters.

STREET OUTREACH

Develop a better understanding of the role of street outreach in unsheltered homelessness.

Enhance Pathways to Permanent Housing

Pathways to permanent housing must be strengthened to make meaningful progress in reducing homelessness and shorten the length of time people remain homeless.

SUPPORT REGIONAL EFFORTS TO IMPROVE CES

through collaboration with regional partners while simultaneously increasing education on and transparency of the system.

STRENGTHEN SUPPORT IN LEASING UP

through additional resources to reduce housing discrimination and other challenges to leasing up in the private market.



STRENGTHEN AND EXPAND PERMANENT HOUSING PROGRAMS

Prioritize and expand PSH, RRH and other long-term subsidy programs. Ensure adequate supportive services in permanent housing programs. Expand support in moving on from PSH.

Reduce Inflow

Reduce inflow into homelessness through targeted prevention, diversion, and cross-systems collaboration.



Promote homelessness prevention through community-based partners



Collaboration with systems that intersect with homelessness.

Systemwide Planning

INCREASE SUPPLY OF PERMANENT HOUSING

through continued investment, maximizing existing supply, and identification of new funding sources

TARGETED APPROACH TO REDUCING CH

through Built for Zero, increasing PH placements, and reducing LOT homeless.

PURSUE OPPORTUNITIES TO EXPAND MENTAL HEALTH AND SUBSTANCE USE SERVICES

through additional supportive services, partnerships, and prescriptive contact language.

ESTABLISH SHARED METRICS OF SUCCESS

to guide community education and data-driven decision making.

INCREASE REGIONAL + CROSS-SYSTEM ALIGNMENT AND COORDINATION

to address inflows, strengthen support services, and streamline regional responses to homelessness.



Improve Equity & Treatment

RESPOND TO REPORTS OF UNFAIR OR DISCRIMINATORY TREATMENT

through assessments and audits, additional support around discrimination in the housing market, greater transparency in service delivery systems, and training.

SUPPORT CLIENT-CENTERED, FLEXIBLE MODELS OF CARE

for housing and service provision to ensure interventions and assistance are tailored to meet the diverse and unique needs of participants

REVIEW WRITTEN POLICIES AND PRACTICES

with an equity lens to identify areas for revision/improvement and develop prescriptive contract language.

ENSURE THAT PEOPLE WITH LIVED EXPERIENCE PLAY A LEADERSHIP ROLE

in overseeing program and policymaking in the CoC.



RACIAL DISPARITY ANALYSIS

conducted on a quarterly basis to inform strategies



HHAP-4 ALLOCATION DISCUSSION

ELIGIBLE ACTIVITIES

1. RAPID REHOUSING

including rental subsidies and incentives to landlords, such as security deposits and holding fees.

2. OPERATING SUBSIDIES

in new and existing affordable or supportive housing units, emergency shelters, and navigation centers.

3. STREET OUTREACH

to assist people experiencing homelessness to access permanent housing and services

4. PREVENTION AND SHELTER DIVERSION

including rental subsidies.

5. SERVICES COORDINATION

which may include access to workforce, education, and training programs, or other services needed to promote housing stability in supportive housing

6. SYSTEMS SUPPORT

for activities necessary to create regional partnerships and maintain a homeless services and housing delivery system

7. DELIVERY OF PERMANENT HOUSING AND INNOVATIVE SOLUTIONS

such as hotel and motel conversions.

8. INTERIM SHELTER

limited to newly developed clinically enhanced congregate shelters, new or existing non-congregate shelters, and operations of existing navigation centers and shelters based on demonstrated need.

9. IMPROVEMENTS TO EXISTING SHELTERS

to lower barriers and increase privacy.




Proposed HHAP-4 Allocation Breakdown

PASADENA'S ESTIMATED ALLOCATION \$800,000

ACTIVITY	PROPORTION	ESTIMATED FUNDING
ADMIN COSTS	7%	\$56,000
YOUTH SET ASIDE	10%	\$80,000
PLANNING	20%	\$160,000
EMERGENCY SHELTER	25%	\$200,000
RAPID REHOUSING	38%	\$304,000
	100%	\$800,000
